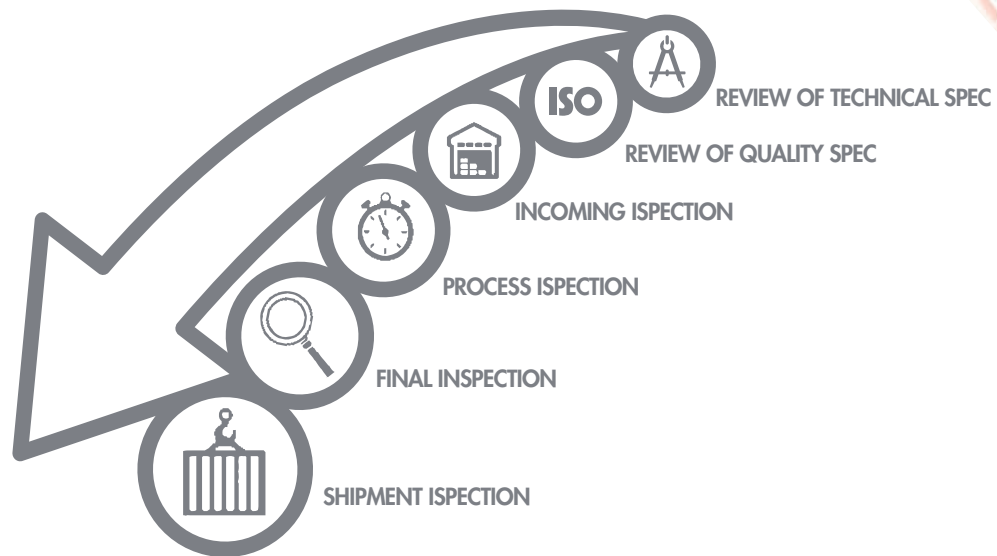
## QUALITY SERVICES MAIN DUTIES

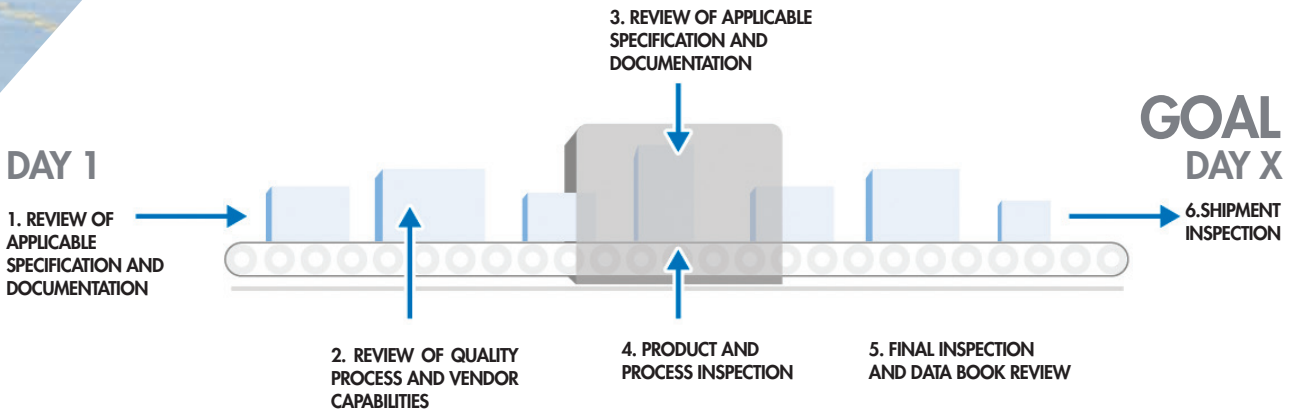
